RESERVATION TERMS

Rentings are allowed from Saturday 4.00 P.M to the next Saturday 10.00 A.M during high season. During low season, stays are possible from 2 nights.

The reservation is effective once the deposit received with the renting agreement duly signed. The balance has to be paid a month before your arrival. On arrival you'll be required two deposit cheques. One of 200 euros for any possible damage, a second one of 50 euros that will be cashed if the mobile-home is not perfectly cleaned before your departure. An inventory and report on state of repair will be made before your departure. You'll be sent the cheque of 200 euros the week after your departure.

On arrival you'll be required a copy of your comprehensive insurance agreement valid for your holiday residence. The tenant has to be present the day mentioned on his/her reservation agreement. 24 hours are allowed, after time and without notice to the renter the reservation will be cancelled. Everyone is liable to take out a cancellation insurance.

Once begun, any stay can't be paid back for early departure. In case of cancellation by mail more than a month before the date of arrival, you'll be paid back the deposit. After time, we'll keep it.

In our rentings we only accept one pet less than 10 kg (Dogs of 1st and 2nd category are forbidden) according to the following terms : set price per stay 15 euros, vaccination book required, vaccinated and tattooed pet. The pet must not lie on the seats (supply a blanket) must not be alone in the renting and must go out of the campsite to do its business.

Our prices include the pitch, the vehicle, the various charges just as the free services of the campsite. The tourist tax is extra, 0, 20 euros per day for any person over 18. If the number of people exceeds the one allowed in the renting, an extra charge of 5 euros per extra person and per night will be required

Barbecues are allowed but you are in charge of them.

Any tenant has to respect the campsite rules.

All our rentings are non-smoking ones.
